Announcing the 2025 Philadelphia Titan 100 Recipients

The annual Titan 100 awards celebration on Thursday, September 18th, will be held at 2300 Arena in South Philadelphia: The best-kept secret of event spaces, a 12,000 + square-foot multipurpose indoor arena tucked quietly under 95 hosting live-streamed WWE and UFC matches, to 76'ers and Flyers fundraising events to private wedding receptions and galas. This unique cocktail-style awards event will gather 100 Titans of Industry for an evening, unlike anything that exists in the Philadelphia business community.
